## **CONDENSED MONTHLY REPORT: SEPTEMBER 2022**

#### I. INTRODUCTION

Our report gives an account of the human rights situation in Burundi, by noting in particular the various human rights violations committed in different localities during the month of September 2022.

- Our report proceeds above all through a contextual analysis of the security, political, legal and social situation in our country.
- Then, it pays particular attention to cases of violations of the right to life and physical integrity of persons, by dealing with:
- cases of people killed and people injured, while highlighting as much as possible the categories of perpetrators,
- cases of torture, inhuman, cruel and degrading treatment,
- cases of SGBV in general and those of rape in particular.
- Finally, we analyse the prison situation at the end of September before concluding on a proposal of some ways to improve the human rights situation in Burundi.

## II. SECURITY, POLITICAL, LEGAL, SOCIAL CONTEXT.

## II.1. security context.

At the security level, the main factors disturbing the peace and tranquillity of the population were, in places, the following:

# 1-Bururi province, Rutovu commune: Two people injured.

September 1, 2022, in the morning, on Munyinya hill, Muzenga zone, Ruvunzo Jean Claude and Eddy Habimana, from the same parent were injured with a machete by Eloge Niyoyankunze, Kevin Bigabo and the named Igor. The victims fell into an ambush, not far from their home, by these two men when they were going to supervise their employees who were preparing the charcoal. Eddy was seriously injured in the head and his Android phone and a sum of 500,000 FBU were stolen by the same group. Land disputes between their families were at the root of this incident. These attackers were arrested and taken to the cell of the communal police station in Rutovu.

## 2-Bujumbura Mairie province, Ntahangwa commune: More than 50 motorbikes burned.

On September 8, 2022, at the terminus of 12th avenue, Kamenge zone, more than 50 motorcycles, which were in a queue to be served with fuel at Gabriel Ntisezerana's BUPP service station caught fire. The owners are demanding compensation as soon as possible because this station was insured.

#### 3- Kirundo Province:

# **♦** Wicked destruction of banana plantations in Bugabira commune.

On the night of September 9, 2022, on Rusugi sub-hill, Ruhehe hill, a 250m by 30m banana plantation belonging to Aloys Bigirimana was destroyed by unidentified people. The police and the administration conducted investigations to identify the perpetrators of this crime.

# **♣** Eight cows killed in Bugabira commune.

September 11, 2022, on Gitwe hill, Kigoma zone, 8 cows belonging to François Mushengezi, a former internally displaced, who voluntarily returned to his hill, were killed in the barn by unidentified people. No investigation has been made to identify the perpetrators.

# **♣** Ransoming of traders in Kirundo commune.

September 24, 2022, around 10 am, in the city center, Kirundo commune, a group of Imbonerakure forced traders who did not show up for community work to pay a sum ranging from 1,000 to 5,000 FBU. No receipt was issued to them. Shops belonging to Mbera, Nizigama, Nkuranga and Nkinzingabo respectively were closed for failure to pay the ransom.

# 4-Mwaro province, Bisoro commune: Three people injured

September 19, 2022, around 11 p.m., on Kanka hill, Vianney Irankunda, Emmanuel Nshimirimana and Emile Nkurunziza alias Siyoni, trader at the Kanka center who were returning home from the cabaret at Emile Nkurunziza alias Siyoni, were injured following an explosion of a grenade thrown by unknown persons. These wounded were first taken to the Kanka health center before being transferred the next day to Kibumbu hospital for surgery. No suspects were apprehended.

#### 5-Cibitoke Province

- **Two miners killed in Bukinanyana commune, September 22**, 2022, on the Bumba hill and zone, Claude Ciza and the named Mpawe were killed following the landslides. Local residents tried to rescue them but failed due to heavy rain. They were buried by their families.
- **♣** Three miners killed in Murwi commune, September 26, 2022, on Gisaba hill, Buhindo zone, Gérard Nganji, Japhet Sinarinzi and the named Karikurubu, were killed following landslides. They were buried by their families.

# 6-Province and commune Kayanza: A beaten child

September 25, 2022, on Kirema hill, Kayanza commune and province, Parfait Iteriteka, aged 12, was beaten with a big stick by his father, Cyprien Minani, for not having washed his clothes which he had entrusted. His right arm was fractured. The child was taken to Kayanza hospital by his parents for medical treatment.

## II.2. From the political context.

# 1- Kayanza province, Gatara commune: Prohibition of three hill notables from the CNL party to take an oath

On September 22, 2022, on Rubagabaga hill, Hassan Ngabiye, Jérôme Barakamfitiye and Chantal Manirakiza from Gisyo hill, elected officials from the CNL party were banned from taking the oath as notables elected on September 12, by hill chiefs, members of the CNDD-FDD party. They were replaced by members of the CNDD-FDD party who followed them on the list. They were accused of having cheated on the required age (at least 35 years old to be notable hillside).

## 2-All the provinces of Burundi: Demonstration march

September 24, 2022, in the capitals of all the provinces of the country, the provincial authorities organized demonstration marches to thank the President of the Republic, Evariste Ndayishimiye for his actions. By way of illustration:

- ▶ In Karuzi province, the participants in this demonstration march were mainly made up of Imbonerakure and CNDD-FDD members who wore their party's uniforms. In his speech, the Governor of this province indicated that the people of Karuzi strongly support the president and the new government. The governor indicated that the population is against those who want to disturb the peace and those who have no respect for the president.
- ♣ In Bujumbura-Mairie, the demonstration march was organized by the Bujumbura Mairie Provincial Section of the CNDD-FDD, under the responsibility of the National Secretary of the CNDD-FDD party in charge of political, administrative and legal affairs, Godeliève Nininahazwe. In the background of the speech and the slogans, the demonstrators supported the action of HE Evariste Ndayishimiye (General Major), President of Burundi, and President of the Council of Elders of the said party who, according to them, has achieved, in recent days, a brushstrokes towards many Bagumyabanga who forgot to be political representatives, preferring to become real wheeler-dealers.

## II.3. From the social context.

Here, we will target the management of the Covid-19 pandemic as well as governance attitudes administrative observed in the administration during the month of September 2022.

# 1- On the fight against the COVID-19 pandemic in Burundi

In Burundi, COVID-19 has been brought under control. However, respecting and applying barrier measures remains a social problem. Similarly, awareness sessions are no longer carried out by the authorized services.

## 2-Muramvya province and commune: Misappropriation of 8 bags of sugar

September 1, 2022, on Burambana hill, Jérôme Bigiraneza alias Simeyoni, head of Burambana hill, CNDD-FDD party member, was arrested by the Provincial Police Commissioner, Police Colonel Edouard Mukoko. He had just been surprised in possession of 8 bags of sugar at his home when he was supposed to have distributed it on his hill. He was released by the Public Prosecutor a few days later.

## 3-Karusi Province

# **↓** Commune Gitaramuka: Authorities accused of embezzlement of funds intended for the rehabilitation of schools

September 7, 2022, around 4 pm, Serges Ntungumburane, aged 42, DCE from Gitaramuka and Félix Nshimirimana, aged 31, communal engineer from Gitaramuka, all members of the CNDD-FDD party, were arrested by police officers on an arrest warrant from the Public Prosecutor of the République in Karuzi and were taken to the commune jail in Gitaramuka. They were accused of embezzling 17,000. 000 FBU, funds intended for the rehabilitation of certain classes of public establishments in this municipality. These funds had been given to the schools by the NGO PADESCO which supports the Ministry of Education.

## **♣** Bugenyuzi commune: Administrative officials involved in the ransom

September 15, 2022, on Gashanga hill, Bugenyuzi zone and commune, Karuzi province, a 43-year-old CNDD-FDD party member, Soter, was caught at his home with several bunches of bananas he had just stolen from his neighbors. Soter has been caught several times in fields stealing. The hill authorities imposed a fine of 175,000 FBU on him, which he paid after selling a piece of his property.

## 4-Makamba province, Nyanza-lake commune

September 25, 2022, during a meeting of the Communal Council of Nyanza-lac, Marie Goreth Irankunda, Administrator of this commune was accused of embezzlement. In September 2020, the municipal council had voted in 2020 a budget for the purchase of a motorcycle used for travel for the recovery of municipal taxes. This authority, on the contrary, rented its own motorbike. Fuel and all costs related to repairs are borne by the municipality in addition to 10,000 FBU of daily rental and this constitutes a shortfall of more than 7,000,000 FBU for the rental costs of this motorcycle alone.

# 5-Muyinga province and commune: Seizure of a stock of hidden drinks

September 21, 2022, from 4 pm to 6 pm, during a search carried out by the provincial police station of Muyinga in collaboration with the communal and provincial administrative authorities in a construction site of Asumani Bucumi located at the Mukoni sub-hill, Kwibuye hill, 270 lockers filled with Primus beer, 49 lockers filled with large Amstel, 29 lockers filled with Amstel bock, 10 lockers filled with Viva, 116 lockers with Fanta were seized during a search.

# 6-Kirundo province, Bwambarangwe commune: Arrest of a provincial chief of Imbonerakure for corruption

September 27, 2022, on Budahunga hill, Abraham Bucumi, provincial leader of the Imbonerakure was arrested and taken to Ngozi prison by intelligence agents from Bujumbura Mairie. They accused him of having distributed a sum of 5,000,000 FBU that Abraham had given him to corrupt members of the communal council. This money was distributed in full meeting of the said council whose object was to dismiss Kanyoni, communal Administrator. The latter had been accused of having sold an electric pump granted to the cooperatives of members of the Imbonerakure militia of this commune to irrigate their fields.

On September 30, 2022, the Minister of the Interior, Community Development and Public Security, Martin Ninteretse sent a letter to the Governor of Kirundo province for the observation of the vacancy of the post of Communal Administrator of Bwambarangwe and to organize elections to replace the fallen authority.

# 7-Ngozi province and commune: Seizure of drugs

September 27, 2022, around 6 pm, on Rusuguti hill, the police who ensure the security of COCO Ngozi arrested two people including Jeannette Kamariza, aged 33, on board of Toyota RAV4 vehicle registered E 3754 A coming from Rwanda, transporting a large batch of drugs. The owners of these drugs were on board of this vehicle and were arrested and taken to the COCO Ngozi cell.

## II.4. From the judicial context

During the month of September 2022, the number of people arbitrarily arrested and illegally detained by Imbonerakure, intelligence agents, administrative officials continued to increase overnight according to the testimonies of the population. But, because these people are often arrested clandestinely, only a few cases could be identified by our human rights observers. Four cases of kidnappings were recorded. In this section, we will also present cases of people convicted in flagrante delicto judgments.

In short and without being exhaustive, at least 68 people were arbitrarily arrested and illegally detained, 4 people were abducted and 6 people tried and sentenced to heavy sentences by TGI, throughout the month of September 2022.

## III. ATTACKS ON THE RIGHT TO LIFE AND HUMAN PHYSICAL INTEGRITY

## III.1. General presentation.

We are dealing here with cases of violation of the right to life and physical integrity in terms of people killed and injured. Thus, as the days go by, human lives disappear without investigations being carried out in order to identify the perpetrators of the crimes in order to bring them to justice and punish them in accordance with the law. The cases of people killed are dominated by corpses found in various places, which cases are mainly attributed by the population, to the Imbonerakure and to National Intelligence Service agents.

Briefly and without being exhaustive, at least 23 people were killed and 19 others injured during the month of September 2022

# IV. CASES OF TORTURE, INHUMAN TREATMENT, CRUEL AND DEGRADING.

During the month of September 2022, most of these acts of torture and ill-treatment have not been identified because they are committed in clandestine cells set up by National Intelligence Service officials in various localities of the country and at the headquarters in the Town Hall of Bujumbura. The cases identified are 8 in number.

# 1-Gitega Province:

#### **♣** Commune Giheta: A tortured child

On August 30, 2022, on Bihororo hill, Giheta zone, Papias Sibomana, 16 years old, a 7th grade student at ECOFO Giheta I, was beaten by Richard Hatungimana, a teacher at this school. This teacher found this child in a family took him, broke his fingers.

The next day, his parents filed a complaint with an OPJ in Giheta. The latter summoned the teacher but refused to appear. Thanks to the intervention of the Public Prosecutor of Gitega, the teacher was arrested, but only spent three days in jail before being released without having been heard.

# **♣** Bugendana commune: A tortured child

September 5, 2022, on Mukoro hill, 16-year-old Joël Tuyisenge was arrested and taken to the Bugendana commune police cell, where, unjustly accused of stealing a telephone, he was beaten by a policeman. After 5 days of detention, the OPJ Léonidas Ndikumana interviewed only Joseph but he refused to listen to the accused and his witnesses.

He rather indicated that Joel must pay 150,000 FBU. On September 13, 2022, the victim's parents, accompanied by defense witnesses, presented themselves to the OPJ, but the latter rejected them.

## 2-Bubanza Province and Commune:

## **♣** A man tortured by police

On the night of September 4 to 5, 2022, in downtown Bubanza, 22 year-old Jean Irankunda, a motorcycle taxi driver, was very seriously beaten before being taken to jail by police officers from the provincial police station in Bubanza, for not having complied ordered to stop when they wanted to search it. Following his worsening state of health, the following morning, he was hospitalized.

## ♣ An National Intelligence Service informant and member of the Imbonerakure militia tortured

On the night of September 9 to 10, 2022, around 8 pm at the bar Atlantique located on the downtown hill, David Hagabiyaremye, member of the Imbonerakure militia and intelligence informant in Bubanza commune, was beaten by Jean Marie, head of the Bubanza provincial police station and S3 of the Bubanza provincial police station. Bubanza police on the orders of Alexandre Ngoragoze, Provincial Secretary of the CNDD-FDD party.

Arrested and taken to the cell of the Bubanza provincial police station, the fellow prisoners refused her detention given the precarious state of her health. The victim was admitted to Bubanza hospital. David had denounced to the authorities a theft of sugar and chemical fertilizers committed by Alexandre Ngoragoze.

## **♣** Gihanga Commune: A tortured person

On September 23, 2022, on Buringa hill and zone, Jules Ndayishimiye, a native of Kigwati II hill, Rukaramu zone, Mutimbuzi commune, Bujumbura rural province was almost killed in the Rukoko nature reserve by Lionel Nshimirimana, driver at the National Intelligence Service, a man named

Moses and a nicknamed Sniper. Jules Ndayishimiye was arrested and tied up by these Imbonerakure who later took him to this nature reserve of Rukoko to kill him, had it not been for the intervention of the inhabitants of this hill. Jules had been accused by them of stealing a cell phone.

#### 3-Kirundo Province and Commune: A Tortured Imbonerakure

On September 11, 2022, at the Shinge-Rugero hotel belonging to the colonel named Anastase, Callixte Ndikumana, nurse, member of the Imbonerakure militia, was beaten, injured in the forehead before being thrown into a gutter of this hotel by Hadji Ndorimana, member of the Imbonerakure militia and teacher, accusing him of spying on them at the time of the meeting of Colonel Anastase and his allies. The following day, Calixte Ndikumana was arrested at his home by the police and taken to the prosecution for detention.

# 4-Rutana province and commune. A tortured person

Following a conflict related to the sale of fuel, which opposed the Governor of the province, Olivier Nibitanga with a certain trader Niyongabo, the latter was taken to the cell of the communal police station on September 17, 2022.

Arrested in his office by the provincial official of the intelligence in Rutana, Pépin Habimana, the merchant Nisubire was beaten up in the presence of the Governor of this province, Olivier Nibitanga, until he urinated blood. This incident followed a message that he had just sent by telephone to his friend Niyongabo while the telephone was in the hands of the head of the intelligence. The message was to inform the President of the Republic that he and his friend, all traders, were being abused by the Rutana authorities more than other traders.

# 5-Bujumbura Mairie province, Mukaza commune: A student tortured

September 25, 2022, around 11 pm, at the Mutanga campus, Nyakabiga zone, Emile Mairo Nduwimana was beaten and injured by fellow Imbonerakure on patrol. Although he showed his documents for identification, he was taken to pavilion 9, the headquarters of these imbonerakure, where he was beaten and stabbed in the throat. His friends took him to the hospital, but the students (Imbonerakure) were not worried.

# VI.2. Comments

The monitoring of violations of the rights of detainees during the month of September 2022, supplemented by the table of the prison situation presented above, shows that overcrowding remains alarming in prison environments in our country and has risen excessively compared to past months. Indeed, the prison population is 12,440 people; prison population represents 2.87 times the capacity of all prisons in the country, which is 4,294 people.

This overcrowding is also reflected in very alarming occupancy rates: 11 out of 13 prisons in the country have occupancy rates that are above 100%. Only the CMCL of Rumonge and the prison of Ngozi for women have rates lower than 100% with respectively 65.28% and 76.40%. The situation is such: most of these prisons in the country have very horrible occupancy rates: Muramvya (798.00%), Mpimba (579.88%), Ngozi for men (402.00%), Gitega (315.00%), Ruyigi (263.67%), Bubanza (243.50%), ...

#### • To the Government of Burundi

- ✓ To take appropriate measures to stop these flagrant human rights violations,
- ✓ To carry out prompt and conclusive investigations to identify the perpetrators of human rights violations so that they can be brought to justice and punished in accordance with the law,
- ✓ To cease arbitrary arrests and detentions with a view to relieving congestion in penitentiary establishments.
- ✓ To reorganize penitentiary structures and emphasize strict respect for the rights of prisoners.

#### • To TFPs

- ✓ To strengthen support for Burundi in all areas and especially in the judicial and security system,
- ✓ To finance Burundi in its activities, in particular those related to the maintenance of peace and security and the protection of human rights.

# • To the population

✓ To remain serene and united, maintain peaceful coexistence and go about development activities and turn their backs on political manipulation.
